I am profoundly concerned by the recent decision to approve changes to previously accepted Rural and Urban Reserves plan. That plan was arrived at through an extensive process including a huge amount of input from citizens. To change it disrepects and defies the very people you are sworn to serve.

I will try to be brief, as I know you have many things to consider. But a plan for the next 50 years has an importance way beyond the "urgent" minutiae of the day.

The 212 acre changes to allow the "road improvements" in areas designated rural reserves will automatically and inevitably bring urban development into designated rural reserves. Increasing development is the primary reason for extending transportation infrastructure - witness the light rail and trolley extensions. These are appropriate things to do in urban areas. NOT appropriate for roads in Rural Reserves. Do not allow these changes to go forward.

I am very seriously concerned about the proposed changes for the Peterkort property.

It is completely unacceptable to negotiate with private owners. This property meets all the criteria of a rural reserve, was so designated, and it is a slap in the face of all legal and sensible persons. There is no justifiable regional or community benefit to be gained by allowing the Peterkort property to become an urban enclave in the middle of a rural area. The idea of exchanging the right of way for non-destructive services for a urban island is completley contrary to the well reasoned principles of a rural reserve. This right of way can be offered without the change in designation.

It is also completely inappropriate to even contemplate placing an urban community in the habitat of some of the last of our larger wild animals such as elk and bear. Splintering, fragmenting and leapfrogging are some of the most important things to AVOID, not to encourage.

The proposed change of the Peterkort property from rural to urban reserves is an extremely bad idea and will degrade forever the Rural Reserves around it and provide no benefit to the general wellbeing of the citizens of Washington County.

I urge you in the strongest possible terms to disallow the change of any of the Peterkort property from Rural to Urban reserves.

Please, let's keep our Metro area as one known for a high quality of life, one not defined by increasing the acreage of asphalt and spotty subdivisions.

Thank you for the opportunity to weigh in on the Metro and Tri-County Urban and Rural Reserves process.

I am writing to you today to request that the candidate Urban Reserve areas north of Highway 26 be designates as RURAL RESERVES under OAR 660-027-0060(4).

With regard to the need for this designation, ensuring the long-term economic security of the region is my primary concern. This area is primarily Foundation agricultural land that currently provides the base for a healthy agricultural economy in Washington County.

As population growth continues in our region, the need for agricultural lands and their unique economic benefit will grow, not lessen. Agricultural lands are a finite resource and their loss to development and fragmentation can not be reversed.

Continuing to protect prime agricultural land that is close-in to urban markets is a key economic advantage that should not be ignored. Agriculture is a global marketplace. Our ability to produce vegetables, fruits, meat and milk for our markets locally - as well as produce a commodity for markets outside the region - is a critical competitive advantage for our region as a whole.

I don't have endless hours to write letters, so will just quickly share my views on a few of the current topics in Washington County.

- 1) Road Right-of-ways Good planning would have avoided this issue from the start. I've always advocated for using natural features (or freeways) as boundaries between urban and rural areas. Pushing urban and rural areas right up against one another often creates unnecessary friction. I'm not alone and that is why so many residents in Washington County fought to keep urban development south of Hwy 26 and preserve rural lands to the north of Hwy 26. With the reserves process coming to a close and with the boundaries now defined we must figure out how to best construct the boundary (a road in many cases) to minimize the friction. Roadway improvements in rural areas create problems for farmers (more traffic, higher speeds, trying to run a tractor along a sidewalk, etc). Rural roads are insufficient for an urbanized area. The best way to address this dilemna is with a compromise. Leave the rural side of the road rural and make improvements on the urban side, as required. I see no reason to convert entire rural roads into urban reserves.
- 2) Peterkort property I can't believe that after all of the reserves meetings and public input, Washington County Commissioners approved this change from rural to urban reserves. It is a sneaky way for a greedy developer to make another buck. This proposed change should absolutely be rejected!
- 3) Standring parcels Here we go again. There is no reason to change the designation of this land to Urban Reserves. If the Helvetia interchange needs to be improved, then the government has the right of "Eminent Domain". As you well know, whatever land is needed for the improvements will be taken from the owner at fair market value, regardless of the urban/rural designation. This property currently meets the criteria for rural designation and should stay that way.
- 4) Undesignated Reserves at NW West Union (758 acres) We need to realize that encroachment of urban development into our most prized farmland is a really big issue. Once it is gone, it's gone! There are plenty of areas where housing developments and factories make sense, but not north of Hwy 26. These acres should be protected for future generations. It is our duty. I hope you truly think about this before allowing any land in the Helvetia area to be urbanized.

I could go on and on about these topics, but my time to write these letters is as limited as your time to read them. I hope that my views and those of other citizens most affected by these decisions are seriously considered when you make these decisions.
